### "GAS METERS"

There was a very dangerous and hazardous situation involving a gas meter that was hit by a car in the early morning hours during the month of May. If it weren't for dogs barking to alert the homeowner this could have very well been an explosive situation. Lone Star Gas was called immediately as well as the Fire department. Within minutes they arrived and capped the meter. They said any kind of gasoline fumes from passing cars or cigarettes thrown out could have caused a massive explosion. The fumes from the gas meter itself produced several dead birds within hours of this leakage.

It is extremely important if you smell gas or you accidently hit a gas meter to call Lone Star Gas immediately.

The number of offenses decreased by one from the previous month of April. The number of burglary of habitation offenses is very alarming since four of these took place at one residence.

Now that school is out, summer is here and vacations are upon us, the Garland Police Department (GPD) has a few tips on how to prevent crime during this season.

"Look at your residence through the eyes of a criminal," said Officer Steve Matlick of the Crime Prevention Unit. "Look for things that can be easily taken or things that could be stolen quickly.

All officers recommend for homeowners not to leave garage doors open, even while you are at home. "Keep garage doors shut at all times, unless you are physically in there. Don't leave it open while you are in the house and don't leave it open while you are mowing the lawn.

Here are some other common sense tips:

- 1. Don't leave lawn equipment in plain view, unattended.
- 2. Don't leave bicycles unattended. Keep them chained at all times, including when they are parked on a front porch.
- Engrave driver's license numbers on equipment, appliances and other valuables.
- 4. Before leaving on a trip, check all windows, doors and gates and make sure they are secure.
- Also, ask a neighbor to watch your house, park their car in your driveway and/or mow your grass.

### INTEREST RATES ARE ON THE RISE

It appears that we may be at a turning point with home values. I am sure that all of you received your tax statement increasing the value of the land in Oakridge. The City is taking the opportunity to increase values so that they can recover some of the loss from the past several years where they have suffered from decreasing home values.

Interest rates are on the rise and with the increase of new home contruction, the buyer is looking in the pre-owned market for a move upward. New home areas are offering incentives to compete with each other. I feel that by the end of this year the pre-owned market will start to see an increase in value as we have less to choose from as consumers. The economics of supply and demand will benefit the seller.

I disagree with Mr. Greenspan and I feel the rates were increased to keep the stock market, already over inflated, from reaching 4000. One quarter of heavy activity hardly constitutes a "boom" market to justify a major recovery of our economy.

If you were looking to move, now is the time. The interest rates will probably stay around 8.5 - 9.0 for the remainder of the year and housing prices will remain stable. Next year will be a new and different experience depending upon where the economy is headed. Stay tuned for more details.......

Other vacation tips include locking doors with deadbolts, disconnecting automatic garage door openers and securing doors with secondary locks and stopping mail and newspaper deliveries.

Another summertime habit that could lead to trouble is sleeping with windows open in the house. "If you sleep with your windows open, get a secondary locking device which allows them to be open only an inch or two," says Officer Matlick.

Police say crimes like burglary, criminal mischief and vandalism become more frequent when school is out and numerous steps can be taken to prevent many of these crimes. Officer Matlick suggested that if citizens see groups of kids gathering together after dark, with the potential of causing trouble, call the police at 911 or 205-2150, non-emergency.

Jo Ann Schmerheim, president brought the meeting to order and followed a printed agenda.

TREASURER'S REPORT-No financial report available, but we have 39 new members and 54 renewals.

### **COMMITTEE REPORTS:**

CRIME PREVENTION-Luanne Payne, chairperson, reported that Lila LaGrassa had attended the Garland Police Crime Watch meeting on behalf of the ONA. Information from this meeting will be published in the Oakridge News. We are still being thanked by policemen for the Christmas dinner which was coordinated and delivered by this committee. Delivery of the Oakridge news has been done by block captains from the crime prevention committee. Sometimes these captains are not available, and lack of volunteers has caused some difficulty in getting the newsletter to our residents.

### **ENVIRONMENTAL**

Ron Harbach, co-chairperson. Homeowners have had questions regarding the brick walls surrounding our neighborhood. Often there is a misunderstanding that the City of Garland is responsible. This is not the case in Oakridge. The homeowner is responsible for repair of these walls. A brick mail box project is being investigated for those who might wish to have one built. The committee is researching costs and feasibility for improving the appear-

ance of the exterior walls with some kind of greenery. In a separate issue, costs for mowing, weeding and picking up trash around the exterior will be determined and reported to the board. Our present maintenance contractor is doing an' excellent job on the entryways.

There has been vandalism of our water valve boxes for our sprinkling system which has required repair in some instances. Padlocks for these boxes were purchased and donated by the Harbachs, to prevent further damage. Deed restrictions continue to be of concern to our homeowners. Any homeowner can pursue violations through the legal system. Legal counsel will be sought to see what the association's role might be in these cases.

FINANCE -Jay Miles, chairperson, will be putting together a 5 year financial plan for the association. This will require coordination with Cindie Johnson, treasurer, for financial data. A discussion was held on the ways and means to establish a reserve fund.

COMMUNICATION -Jo Ann Schmerheim indicated there is no communications committee at this time. She has been doing what ever it takes to get the newsletter published. A search for this committee will be ongoing. In addition, this committee is responsible for our voice mail (or hot line). Jack Rash has been handling this on an interim basis. We need a volunteer that could call and retrieve the messages on a daily basis. A summary form will be developed by Bonnie Fisk for use by our chair people to capture the activities of their committees. The information on these completed forms will be used to publish their reports in the newsletter. In addition, Bonnie will write a summary of the board meetings for the newsletter. Homeowners can use the hot line for lost and found pets. An article will appear in the newsletter on this topic.

MEMBERSHIP- Pat Downing, interim chairperson, has completed one term As head of this committee and would like someone else to volunteer. There has been difficulty getting volunteers to help with membership responsibilities. Approval was given to buy stamps for mailing renewal membership invoices. The Oakridge Neighborhood Association Directory is completed. Copies will be distributed to members by volunteers.

### **FUND RAISERS**

Last year's pumpkin sale and poinsettia sale were both successful and should be held again this year. Other suggested fund raising projects will be considered.

### COMMENTS BY THE PRESIDENT

An Oakridge senior citizen who could write an article on senior issues for the newsletter would be most welcome.

A bylaws committee will be appointed to review our present bylaws and make recommendations for the next year.

Peggy Richey will write an article relating to the Oakridge Country Club. In order to promote the ONA at Splash Day several board members volunteered.

The Oakridge Country Club mailed the newsletter last month. All members would have received a copy, as membership labels were supplied to the Club. Other residents could have been missed as it is often difficult to get up to date mailing lists.

The next general membership meeting is tentatively scheduled for September 15th at 7:30 P.M.. The board meeting will be held on August 24th at 7:00 P.M. The meeting adjourned at 8:25 P.M..
