# Rash Statements by Jack Rash Civic & Political Interest Committee

I hope all of you attended the public meeting last week, and provided your ideas and opinions on the DART Light Rail System in Garland. You've already expressed your opinion (two or three times, now) that you want light rail in Garland. The meeting last week was to find out how you want it to *look* once it's here.

In case you missed that meeting, you'll have other opportunities to express your opinions. In fact, you can "officially" express them to me, since I am now a diligent member of the Garland/ Northeast Corridor Light Rail Advisory Committee.

At the first committee meeting, two DART staffers gave us the complete history, current status, and future plans of the entire system. They told us that, when completed, we'll be able to zip down to Mockingbird and Central in 16.2 minutes, although I don't know why we actually would want to do that.

Many things must be decided before that happens, though, and this is where YOU come in.

Garland will have two depots, three if you count the one at Plano Rd. and Forest Lane that will be built *if* ridership warrants it. The two Garland "kiss-and-rides" (a technical term I learned at the first committee meeting) will be at Forest Lane and Jupiter, and at the Garland Transit Center, which is the existing DART kiss-and-ride across from the Garland Performing Arts Center.

We citizens of Garland can and should have a say-so in how those two or three terminals look – beyond, of course, what is dictated by DART and its master plan. The terminals will all look the same in the basic design, as you can see now on the operating Oak Cliff line.

Unfortunately, we have to decide fairly quickly such things as what amenities should be considered for the terminals, what environmental impact we think the line will have on our neighborhoods, what effect the line will have on traffic flow, and a whole notebook full of other things. At least one of the major issues to be decided is whether the line will need to be elevated OVER Forest Lane near Jupiter. Traffic on Jupiter, particularly at rush hour, is right at the volume DART sets as its limit for an "at-grade" (meaning the track cross **through** the road) crossing.

There also is talk of creating a pedestrian mall between the terminal at the Garland Transit Center and the downtown square. There are some implications to that, and to all the decisions that have not yet been made.

Whatever else we do, I think we should start referring to the terminal at the Garland Transit Center as "Grand Central - Garland" or some other "creative" name. Garland Transit Center sounds too sterile and lacking in any real character.

Your opinions and suggestions will be what puts the character in the Light Rail system as it zips through our fair city at 41.3 mph.

# Crime Prevention and Safety

#### **CRIME STATISTICS FOR FEBRUARY 1996:**

1 - Vehicle Burglary Big Oaks

1 - Theft \$20 - \$200 Moss Trail

1 - Theft Under \$20 Hickory Bend

1 - Criminal Mischief Big Oaks

The statistics for February of 5 offenses were half that of January, which reported 10 offenses and one-third that of a year ago at this time (15). This is a dramatic decrease when comparing last year statistics to this years. It looks like we are doing something right.

The C.O.P. (Citizens On Patrol) program should be in effect by the first of April. Hopefully, when this patrol program gets off the ground we can continue to see a decline in all reported offenses. But remember, you have to do your part by keeping your garage doors closed to cut down on the burglary of habitations and also by keeping your cars parked in the garage or in the driveway to prevent vehicle burglaries. With the warm weather we are all out working in our yards and if you leave your garage doors up while you are in the front yard this is a prime opportunity for someone to walk into your garage and gather up tools, bikes, or whatever else can be picked up easily and put into a waiting vehicle.

Here is an interesting statistic I would like to share with you about the success of the Juvenile Curfew Ordinance.

- A. For 18 months prior to the enactment of the ordinance there were 3,871 offenses reported listing juveniles as suspects during ordinance hours.
- B. For 18 months following the enactment of the ordinance there were 2,788 offenses listing juveniles as suspects during ordinance hours.
- C. In the months following the ordinance, 70% of the violations occurred during the week and the remaining 30% occurred on week-ends.
- D. This reflects a decrease in criminal offenses involving juvenile suspects of 28%. The ordinance does appear to be very successful.

#### **HOMEOWNER INSURANCE ALERT**

#### What Condition is your ROOF?

There are major changes in the coverage for homeowners where roofs are concerned. I have spoken with several different insurance agents from several different companies. Let me share with you the many comments made to me. Effective January 1,1996 there have been additional changes. Here goes:

- 1. Some companies will not insure wood shingle roofs with composition overlays.
- 2. Some companies want a minimum of 15 years life left on the roof for a normal 500.00 deductible. It is common to see a 1% deductible for any roof damage due to hail or wind. If the roof is between 5-10 years they still want a 1% deductible. The industry is trying to lobby for a 1% deductible for hail and wind regardless of the life of the roof.
- Some companies will not allow a second roof overlay, but in order to insure the property are requesting a tearoff and only one layer of composition shingle.
- 4. Some companies are not writing new business in Dallas County in the area because of their heavy losses. This is not new except that the number of firms not writing the business is growing.

If you are looking to sell your home and your roof is the original or it is wood shingle, you need to discuss these items above with your insurance company. They are causing many problems with the sale of properties in the area. All insurance companies have different requirements, but it would be wise to know if you will be forced to replace a roof in order to sell your home. Without insur

ance, the lender will not give the new buyer a loan. I think that we will be seeing some major changes in the insurance industry regarding this problem as many of them have had major financial blows because of our weather and storms.

#### **BLOCK PARTIES**

There are some streets that have had very sucessful Block Parties. It is a fun way to meet your neighbors. Following is the city's procedure for planning a Block Party. If you need more information call the ONA Hot Line 220-2286

#### DEPARTMENT PROCEDURES FOR BLOCK PARTIES

- 1. Request approved only for Residential classified streets.
- 2. Request to be approved by the following City Departments: **POLICE, FIRE and TRANSPORTATION**
- 3. The applicant must submit a petition with the signature of all residents directly affected by the block party to the Transportation Department. The petition must be received and "time stamped" a minimum of 1 day in advance of the date of the block party.
- 4. The applicant shall provide the following information:
  - A. Applicant Name.
  - B. Applicant Address.
  - C. Applicant Telephone Number.
  - D. Proposed Date, Time and Street to be used for block party.
  - E. Alternate person to contact in emergency, if applicant is not available.
- Permitted time for block party shall be between 9:00 AM and 10:00 PM. No party shall begin before 9:00 AM nor extend beyond 10:00 PM.
- 6. Applicant shall be responsible for removal of all trash, refuse, etc., from the street within 8 hours after the party.
- 7. No alcohol beverages permitted within street right-of-way.
- 8. Transportation Department will provide to the applicant residence, barricades, cones and/or signs. The street shall be barricaded at the nearest adjacent intersections.
- The applicant shall remove the barricades, cones and/or signs immediately after the party and store the material at his/her residence for pick up.
- 10. Transportation Department will pick up the material the following regular work day after the party.
- 11. The street closure shall be in a manner to permit emergency vehicle entrance without undue delay.
- 12. Fire hydrants shall be kept free and clear of obstructions.
