IMPORTANT FACTS TO BENEFIT OAKRIDGE:Junior forgot he needs brownies for the bake sale

Here is some helpful information to make you aware of just a few of the code violations that can be easily corrected by making a simple phone call to Code Enforcement at 205-3374:

WEEDSWeeds or grass of 12" high are
a violation of Garland's City
Code. Property owners and tenants
are responsible for keeping lawns
mowed. If the city has to cut the
weeds, you will get a bill for
mowing services plus administrative
fees.

<u>JUNK VEHICLES</u> Motor vehicles that do not run, partially dismantled or have expired license plates or stickers are "junk vehicles". They cannot be kept where they can be seen from the right of way or from nearby private property.

<u>OPEN STORAGE/</u> <u>NUISANCE</u> Outside storage is not allowed \except for items made of weather resistant materials which are intended for outside use, such as lawn furniture and landscaping items.

<u>PARKING ON THE</u> PROPER SURFACE

Motor vehicles in Garland must be parked on a driveway or an improved surface. <u>Parking on the lawn is</u> <u>not allowed.</u> You may park on the street when it is permitted. and you're already late for work! LET SUE DO IT

Although this gives us some good information, there are many variables that may change these values. For example: If you add on and you now have the largest home is the neighborhood, you may have over-built for the area. It also depends on the finishout and design of the addition or redo. There is also a big difference in adding lots of shelves and built-ins to a back bedroom and turning it into an office rather then adding a library-study.

It is important to make a distinct difference between the need to update, which means changing old vinyl, carpet and papers because they are old and worn out and replacing with new or updating your vinyl to today's tile or wood floors. This may be necessary to sell your home and compete in the market place. Sometimes you can reap large rewards by remodeling and can be less expensive in the long run then selling and buying again.

There are lots of choices and many times it depends on your particular circumstances and needs as to which might be to your advantage. Over-the-Counter Painkillers: Friend or Foe? Dr. Ann Knight, DC

Many people take over-the-counter painkillers for their pain. This would include Aspirin, Ibuprofen (Advil, Nuprin, Motrin, etc.). Acetaminophen (Tylenol, Anacin-3, etc.), and Aleve or Napyroxin. Aspirin was the first of these drugs to be introduced by a German drug manufacturing company, Farbenfabriken Bayer over 70 years ago. Many people have benefited from this drug's anti-inflammatory and fever reducing properties, but it wasn't until the late 1960's that we began to understand how this "miracle" drug works.

A pharmacologist in England discovered that aspirin destroys an enzyme that controls the production of all prostaglandins are chemicals produced by

the body in different several forms. Some of " b a d " the prostaglandins l e a d t o inflammation. pain, and blood clotting. Other good" prostaglandins, however, work to reduce pain and inflammation and promote to healing. Aspirin all of destroys "bad" them as well "good". as

In the short term aspirin does seem to have some beneficial effects, however, long term use can lead to internal bleeding, ulcer development, and depression of the immune system. There is also a potential to develop an allergy to aspirin with long-term use.

Additionally, aspirin interferes with the production of molecules. called glucosaminoglycans, that are produced to build healthy connective tissue and cartilage within the body. Without these molecules the cartilage within the joints cannot reproduce itself correctly. This may lead to wearing away of the joint surfaces and over a period of time, arthritis and pain in the joints many develop.

DR ROOF

ATTIC VENTILATION OFTEN AN **OVERLOOKED ITEM DURING RE-ROOFS**

As I have been working in the neighborhood during the form of roof ventilation with their jobs but so recent wave of re-roofing, I have had the opportunity to observe the design of the roofing systems being built by various roofing companies. One thing which was most notable was the lack of design and installation of an adequate attic ventilation system, particularly when changing from a wood shingle roof to a composition roof. A wood roof freely passes air through and around In the summer the sun heats the roof surface to the shingles. Go into the attic of a home with a wood temperatures sometimes exceeding 160 degrees. roof and quite a bit of daylight can be observed. When this covering is removed and replaced by asphalt composition material, it effectively seals it off tight.

It is not our belief that this discrepancy is caused by any other reason than a lack of knowledge and

understanding of what is needed and how to install it by some contractors. Most include some often little thought is placed on what is really needed and where should it be located.

A properly balanced attic ventilation system is essential for not only the health of your home but also your pocketbook.

This heat radiates into your attic causing high attic temperature. Without the efficient removal of hot attic air, the heat bakes through your attic insulation and turns your ceiling into a large radiant heater. This places an excess load on your



air conditioning and also robs cooled air from the ductwork in the attic before it gets to your living area. High attic temperatures impede heat dissipation of the shingles and they run at such high temperatures that premature shingle failure almost always results. The end result is a less comfortable home, premature replacement of your AC unit, and roofing material, and higher utility bills.

In the winter months attic ventilation is equally important. Warm moist air from bath, kitchen, wash, and expiration migrates to attic areas where without proper ventilation it is trapped. Cold wind to the roof of the home causes this moisture to condense on the underside of the roof decking leading to a myriad of problems including warping of the decking and structural damage, water soaked attic insulation, structural rot, mildew, and peeling paint with the associated expense of wasted energy and increased home maintenance.

It is not difficult or expensive to design and install an adequate system and for most homeowners the additional comfort and savings makes sense. Also without such a system, if there is ever a warranty problem with their composition shingles, the manufacturer of the shingles will deny The Uniform Building coverage. Code 1991 and FHA calls for a minimum of one square foot of Free Vent Area (FVA) for every 300 square feet of attic space if half the FVA are intake vents located under the soffits and half the FVA are exhaust vents located at or near the peak of the roof. HUD calls for one square foot of FVA for every 150 square feet of attic space located under eave or at the ridge. You may elect to install anywhere between these figures. Once again it is important that however much you Diane Owens Add

decide to do, make sure the system is balanced. A balanced system will have equal intake as exhaust. Some schools of thought allow for 60% of total FVA as intake and 40% exhaust.

To calculate what your needs are, measure and draw a sketch of the total perimeter of your home from eave to eave including any area which has attic above it such as an open patio. Divide the resulting drawing into rectangles. Most homes will have a bedroom wing as a rectangle, the garage as one and the main portion of the home as a third. Some of the homes in the neighborhood have multiple front hips or offsets which will also need to be figured. Multiply Width X Length of each part and add the resultant (continued on page 12) figures for the total square footage of your attic. Take this figure and divide by 300. The result is the total minimum

Effects of Nonsteroidal Anti-inflammatory Drugs of Prostaglandin's and Renal Function, printed in The American Journal of Medicine in June, 1985. An Abstract quote form this article is:

In the past 15 years, there has been an explosion in the number of Nonsteroidal anti-inflammatory drugs on the market. Along with this explosion have come increasing reports of the physiologic and pathologic changes in the kidneys.

<u>The Harvard Health Letter</u> dated November 1990 states that nonsteroidal anti-inflammatory drugs (NSAIDs) are one of the most widely used drugs

in the United States. This article sites a study done Hopkins John at School University of Medicine that indicates that even doses of six over-the-counter tablets of ibuprofen can produce reduced kidney function. The article also states that University Sanford researchers estimate that gastric bleeding is the most frequent and severe side effect drug of NSAIDs in the United States for patients taking the drug for Rheumatoid Arthritis, causing 20,000 hospitalizations and 2.600 deaths each year for these rheumatoid arthritic patients.

The Oregonian, November 22, 1993 titled, <u>Bad</u> <u>News: Headache Medicine Can Cause</u> <u>Headaches</u>, cited that people who are headache prone and take drugs such as aspirin, acetaminophen, and ibuprofen regularly can have analgesic rebounds such that the pain killer can actually induce a headache. Dr. Robert Ford of Ford Headache Clinic states that people who are headache-prone can have analgesic rebounds by taking Tylenol as little as two times per week.

Over-the-counter pain killers should not be taken on a regular basis for any length of time. There is no definite answer to how much is too much, but if you are taking these pain killing medications for more than a few doses, one should begin to look deeper to determine the cause of the pain rather than just masking it with these potentially dangerous drugs. Consult a licenced doctor who is skilled in

FVA required. Dividing by 2 gives the requirement for intake and exhaust. As all vent devices FVA is expressed in Square Inches we need to multiply the Square Foot FVA figure by 144. (Sq' Attic Space / 300 = Minimum Required FVA) (1 Sq' = 144 Sq'') (Length X Width = Area of a Rectangle)

Most homes in Oakridge are equipped with a number of 8" X 16" intake vents under the soffit of the home. These provide for 65 square inches each of FVA if they are unobstructed and not painted over. Count these first and multiply by 65 to find what you have in existing intake. Check this figure with what you calculated is required. You may have to add some or you may have Remember, you will want to balance enough intake with exhaust ventilation which is where most of your homes are lacking. It makes little difference what type exhaust vents are used. Some of the more common are static ventilators, which look like a low 12-14" inch square metal box close to the peak, ridge venting, or wind turbines. These devices typically provide a FVA of 60 square inches, 16 square inches per linear foot, and 113 square inches for a 12" and 154 square inches for a 14" turbine respectively. Most all the turbines on your homes at the present are 12" models. Be careful not to mix different types of exhaust vents. A turbine located near an exhaust static vent will draw its air from that vent effectively short circuiting the system.
