President's Message - Donna Dayhoff

The Board and myself would like to thank all the members, who attended the March Membership Meeting. Our program on Code Enforcement was very informative in letting us know what the City can enforce. Dr. Kim Haynes, City Veterinarian explained to us about the "new" leash law, which states "your pet must be under control of the owner at all times if out of a fenced-in area." This means that even in your own yard (if not a fenced-in area) your pet should be on a leash.

The Code Enforcement Department representatives referenced City Sign Ordinance 5045 for our information. This ordinance refers to contractor, realty and campaign signs. On contractor's signs they should go up 24 hours (1 day) prior to work beginning and must be removed by 5:00 p.m. the day after the work is complete. All signs (contractors, realtors and campaigns) must be placed in the homeowner's yard not in the parkway. The City can pull these signs up if they are not in compliance. Homeowner's please keep this in mind - so that our neighborhood does not look like a "war zone" or a "campaign rally." The way our neighborhood looks should matter to us ALL!

We are getting close to starting another year for the O.N.A. One of the changes you will notice for 1998-99 is we have added two new District Directors. We will have seven districts instead of five. This change was done with the by-law changes approved at the March Membership Meeting. In adding two more districts, the residences will be better served because this makes each district have approximately the same number of residences to serve. More information will be in the May newsletter explaining whose district your home will be in starting in June.

We would like to thank Mary Fowler for being District One Director for the past year. Mary has resigned and in her place we welcome Judee and Jay Houston.



Brush & Bulky Items Collection

Residential yard waste, brush, appliances, furniture and other bulky items which are too large to fit into the green trash cans are collected once a week. Collections for Oakridge is scheduled for every Tuesday. If it is not picked up on Tuesday it will be picked up on Wednesday. Sometimes they run behind depending on how large the collections are.

Items that <u>will</u> be collected are: brush, tree limbs & tree trunks, bagged leaves & grass clippings, appliances, furniture, plumbing fixtures, fence material, lumber, insulation, gypsum board (broken & placed in cardboard box), siding, paneling, flooring, carpet & pads, plastic sheeting & plastic laminate, piping and wiring.

Items that <u>will not</u> be collected are: roofing material, concrete, asphalt, rocks, dirt, bricks, tires (with or without wheels), unbagged garbage or trash outside the trash container, bagged garbage or trash outside the trash container, lawn waste or construction debris generated at another address (contractor waste).

Acceptable bulky items (including appliances) can be placed at curbside after 6:00 am the day before the scheduled collection day. Lawn waste (bagged leaves, grass clippings or brush) may be placed at curbside any day of the week. For further

Animal Ordinance Changes

Some changes have been made at the Garland Animal Service. The Animal Services Ordinance has been updated to enable the City to deal with trends in pet ownership and other animal service issues. Adoption fees will increase from \$29 to \$60. This new price includes sterilization, City registration and rabies vaccinations.

City registration fees will change to \$10 for unsterilized cats and dogs over six months old. Sterilized pets or those under six month of age will be registered for \$5. Ferrets, pot-belly pigs, pygmy goats, and certain reptiles are now allowed by <u>permit only</u>. Owners of these animals must meet specific requirements and pay a \$25 annual fee. Roosters and peacocks are no longer allowed.

Also, you must have your dog on a leash when in an unfenced yard. This applies if you are working in your front yard with your dog. The dog must be restrained by a leash or you could be fined if Animal Control happened to drive by. They say you never know how your dog will react if another dog or cat was out or an individual was walking by. This is for your protection as well as the other person. Treasurer Report - Dan Jones

Dan presented the 97-98 budget for approval. He stated that we have a yearly income of approximately \$22,288.00. Clara Mae Meurer made a motion to accept the budget and Cy Farver seconded it. The motion passed. The majority of our money is spent on maintenance and the rest is spent on postage, newsletters, and welcome wagon. Yearly income is from membership dues and passbook sales. Expenses to date are \$13,408. Current balance is \$17,709.42.

Call the police and report it. This month several green trash cans were stolen or either blew away from the property during all the high winds we have had during the past month. This was reported to the police all over Garland as being stolen, which increased the monthly crime statistics for the whole city. One more note on this, the trash cans are only supposed not to be put out before 7:00 pm on Monday and brought back in by 7:00 pm on Tuesday. If you have no room for these lovely bins in your garage, you might be able to put it in a more secluded place.

If you have a home security system that is audible from the outside, there is a city ordinance that you must be registered with the Garland Police Alarm Division. This permit is only \$20 every two years and can be obtained by calling 205-2127. Whether your alarm system is monitored or not, a permit is required. If your system goes off and a concerned neighbor calls to report it to the police, you could be fined \$255 if you do not have a permit with the Garland Police department.

Call Before You Build

Before adding a storage building (i.e. Morgan Bldgs.), detached garages, decks, porch covers, or any other structure, you need to call Building Inspection at 205-2300. Restrictions as to size and placement of these structures vary within the city and building permits are required. Pools, hot tubs, garage conversions, carports, and many other improvements also require building permits. If you do not check with Building Inspection before you build and get a permit, you could be asked to remove the structure or pay a very steep fine. This has happened on numerous occasions because of the size and placement of the structure did not meet the restrictions.
