

<u>PRESIDENT'S MESSAGE</u> - Donna Dayhoff

Here we are starting our seventh year as an Association. The Board and myself would like to thank all the residents, who have been supportive over the years and hope to welcome more new members this year.

As you read in a previous newsletter, we have added 2 new District Directors to the Board bringing us to 7 districts. This was done to help serve the residents better within each district. In another article your street is listed with your district number and director's name.

Update of Proposed Retirement Community – As members, you have been made aware in previous newsletters that Golden Living Development had asked for a rezoning of property located on Buckingham Road, east of Shiloh and west of Winding Oak from Single-Family to Multi-Family zoning. The homeowners and the O.N.A. Board of Directors met with the developer and voiced their concerns before this issue went to the Planning Commission's meeting these concerns were again voiced and asked to be added to the Plan Development for this rezoning. The developer agreed to have age requirement, transportation, adjustment to building heights on the north and west sides and some other details added. The Planning Commission approved the Plan Development including these concerns.

The next step was a Public Hearing at the City Council Meeting on May 5th. The homeowners within 400 feet of the development were sent notification of the Public Hearing. A representative spoke for Oakridge voicing the concerns and asking that if approved; it be based on the concerns listed from the Planning Commission. The Council at the Public Hearing made approval. On May 19th the final approval was brought to the new City Council and was denied for various reasons.

At the O.N.A.'s General Membership Meeting on May 27th, our District 7's City Councilman, Lowell Hyatt, asked if the residents would support a reconsideration of this issue to be brought back to the City Council for further review. An informal vote was taken with the majority of those present supporting a reconsideration which would take place if approved at the June 2nd Council meeting. This was done and passed 6 to 3. This means another Public Hearing would be held at the July 7th Council meeting. Again the homeowners within 400 feet of the development would be notified.

To our knowledge at this time the developer has not made a decision in pursuing the reconsideration.

The O.N.A. Board agreed to set up a meeting with the developer and residents of Oakridge if they decide to pursue the matter. As of the printing of this newsletter, we do not have any further information on the status of this matter. If the developer decides to pursue this rezoning again, a date of June 30th has been set for the meeting at Oakridge Country Club at 7:00 p.m. Signs will be put out at the entryways notifying residents that meeting will take place and will be on the Hot Line. Any interested homeowners are welcome to attend.

The O.N.A. Board is not taking a pro or con stand on this issue. Our only concern is keeping the residents informed about what is happening in their neighborhood.

I would like you to welcome your 1998-99 Board of Directors and thank them for volunteering to help make our neighborhood "the best".

This would have made a total of 8 offenses for April and only 2 reported as of this date for the month of May.




From the Membership Office at Oakridge Country Club

<u>WARNING</u> – "A New Roof May Be Hazardous To Your Health"

Even if you have not had your roof replaced, you would have to be blind and deaf to not be aware of all the roofs being replaced in Oakridge.

A roofing contractor is not required to obtain a permit unless your roof is to be redecked. (Example – A wood shingle roof is replaced with a composition roof.) Even then, not all contractors get a permit and have an inspection by the City Code Enforcement Department.

Here – in lies the danger – when a new roof is installed, the roof flashing for the gas furnace and water heaters must be raised or moved in order to get a proper seal to protect against water damage from precipitation. Very often, the contractors inadvertently pull the vent below off the water heater or furnace. There is also a chance the vent can be broken. In both scenarios this will allow carbon monoxide to escape into the attic or worse into the dwelling. This can seriously injure or even kill the unsuspecting resident.

There is also another, equally dangerous hazard, according to manufacturer's guidelines and heating and plumbing codes – all vent flues shall have a "minimum" of one inch (1") clearance from <u>all</u> combustibles including wood, paper, tar paper and composition shingles. Often, the flashing is moved and you lose this important clearance.

Having nearly forty years experience in the heating and air conditioning business, I am aware of several tragedies caused by the exact conditions I have outlined.

Just this year, I have inspected 3 re-roofed homes of friends and family and in <u>every</u> case I have found 1 to 4 serious violations.

What To Do?

- (1) You could call your roofing contractor, who replaced your roof. (I called the roofer back twice on one of the aforementioned jobs and finally had to call a heating contractor to get the problems resolved correctly.)
- (2) You could have the City Code Enforcement Department inspect your roof (inside the attic) but as hot as it is they may not be able to get in the real tight places and even if they do find a violation, you still would have to call someone to fix the problem.
- (3) Protect yourself and <u>your family</u> by having your flue vents inspected by a qualified licensed heating or plumbing contractor. Even if you have not had your roof replaced and especially if you have.
