



NEIGHBORHOOD VITALITY

What is meant by "NEIGHBORHOOD VITALITY"? This phrase could have several different meanings. In Garland that is certainly true. For the older parts of Garland it could have quite a different meaning than in the newer sections of our City.

In the older parts of Garland it means trying to do things in these neighborhoods to slow down or stop the decline or decay and deterioration of these areas. As neighborhoods get older they sometimes tend to start to look bad, properties have a runddown appearance, etc.

How do you stop this problem? In Garland, our Neighborhood Vitality programs address things with the citizens such as keeping your lawn mowed, maintaining your alleyway, keeping fences in good repair, keeping your house painted, etc. In general, just maintaining your property properly. This applies to both homeowners and rental property owners. One of the most important things is have a sense of pride in not only your property but in the entire neighborhood in which you live and to encourage your neighbor to do the same.

How does the City Of Garland help out? By having programs that help citizens attain these goals. A few examples are: furnishing paint or building materials and having volunteers to furnish the labor in some cases to paint the house or make minor repairs. Providing low cost or forgivable loans to those whose property need major repairs. Having a program to build new single family housing for those who qualify and move them from being a rental property tenant to a homeowner. For people who are no longer physically able to mow their lawns, there is a program to provide this service to them. The City can also install new streets and sidewalks where needed, contributing to a better general appearance of the area.

A lot of the older areas of Garland do not have the benefit of having a Homeowners Association and the benefits that go

with being a member of such an organization. This makes it much harder to preserve the vitality of a neighborhood. I live in a neighborhood that was built mostly in the early 1950's. It has been a very stable area for many years but a Homeowner's Association was never established. In the last few years some of the properties are beginning to change ownership. Some of it is becoming rental property. The residents of my area need to be vigilant in maintaining their properties or this area could begin to slide into decay. Just because a neighborhood is getting old doesn't necessarily mean that it should automatically start to look rundown. With proper neighborhood participation and involvement, this can be avoided.

Neighborhoods with established Homeowners Associations have the tools in place to prevent decay from ever happening. They have an established set of rules for the property owners to go by, they have a high sense of pride in maintaining their property and of keeping their whole neighborhood looking great. Neighborhood Associations can play a vital part in preserving the well being of an area, but it still takes the willingness and participation of each citizen to make it work.

Information from Councilman Lowell Hyatt

Fire and Police Calls for Service:

I thought the following information relating to calls for service during New Year's Eve and New Year's Day would be of interest to the readers of this newsletter. The information was included in a memorandum from the Emergency Management Coordinator to the City Manager.

Fire Department call for service;

December 31 7pm -12am 1999 48 calls - 1998 23 calls January 1 12am - 7am 2000 20 calls - 1999 22 calls January 1 7am - 12am 2000 36 calls - 1999 23 calls

Police Department calls for service/ or Officer initiated (all available police officers were on duty)

December 31 7pm – 12am 1999 171 calls -1998 133 calls January 1 12am - 7am 2000 237 calls -1999 187 calls January 1 7am - 12am 2000 369 calls -1999 293 calls

The overall impression from police was that activity was much less for this year than last year. The numeric increase may have been a result of an increase in officer initiated activity since every available police officer was on duty. Dispatchers reported fewer calls/requests for service from the community.

Excellence Awards Luncheon

The Garland Health Department held its annual Food Sanitation Awards luncheon on December 17th. Awards were given to 41 establishments. Four of the establishments are located in that portion of Garland bounded by Beltline, Jupiter, Campbell Road and Garland Avenue. The Firewheel Golf Park and 19th Hole at Firewheel also received awards.

The names of the four establishments are David's Meat Market (4010 N.Jupiter); Bleachers Sports Grill (3402 Arapaho) Wonder/Hostess Outlet (1821 Beltline) and Whistle Stop Station (1966 Arapaho). Bleachers Sports Grill and Wonder/Hostess Outlet are two time winners, Whistle Stop Station is a three time winner and David's Meat Market is an eight time winner. I do not know the number of times the two establishments at Firewheel have received awards.

David's Meat Market has the distinction of being the only food establishment in Garland to have received an award each year awards have been given. It competes in the Supermarkets & Meat Markets classification and competes with the other 29 establishments that classification. That classification is one of the nine classifications in which the 703 food establishments in Garland are divided.

The number of inspections conducted by the Health Department at each establishment at each establishment each year ranges from one to four and is based on the food served and past compliance history of that establishment. An award is given to each of the food establishments with an average inspection score that year which falls within the top 5% of the scores in that establishment's classification.

Receiving an award from the Garland Health Department is quite an accomplishment. That Department has a reputation for conducting tough inspections. It also has a reputation for always being fair and consistent.

A Crime Watch Experience by Bill Johnson

Recently a home across the street from me on Rolling Oak was broken into. It was entered through a garage door that was in poor condition and easily breached. Apparently a neighbor across the alley alertly noticed the illegal entry and scared the burglars off before anything was taken. The Police conducted an investigation, but I am unaware of their results.

The reason I mention this is because I believe I actually saw the burglars. The illegal entry occurred about 8:00 am on a school morning. As I glanced out my kitchen window around 8:20, I saw three people walking across the front yard of a house facing mine. My impression at the time was that they were teens of high school age, and I wondered why they weren't already in school. When they turned to go between two houses, I still wasn't concerned since kids often cut between houses in our area. But, when they reached the alley they behaved rather oddly. One crouched down alongside a fence and peered down the alley to the left. One hung back from the alley. The third one went to the right behind the house. Then they were gone.

Their behavior should have triggered my alarms but, sad to say, I didn't follow up. Later when a police cruiser passed my house and then went up the alley on the other side, I berated myself for not reporting the odd behavior I had seen. Later, I did flag down a Police investigator and

briefed her on what I had seen. But, I felt badly about not acting earlier, given what I had seen.

Later that same day I noticed another house on my alley had it's garage door left open. I tried to contact someone at the house to no avail, and reported this situation to the Police. They came by, checked it out, found no problem, and closed the door.

I encourage all our residents to be alert to behavior that is out of the 'ordinary'. Better to be safe than sorry. If you see something that doesn't look right, please call the Police dispatch number (972-205-2150). They will investigate.
