

# <u>The Census</u>

In less than two months we will be receiving our 2000 Census forms. It is time for all of us to stand up and be counted! Why is responding to the Census so very important? Why is obtaining a complete count so difficult?

Redistricting is the major constitutional purpose for conducting a Census. This involves not only deciding how many congressional representatives each state will have but also where state senate and house districts will be located and where county commissioner, city council, school district and many other jurisdictional lines will be drawn. States also receive their share of federal funds based on the Census count.

The Census Bureau estimates Texas' undercount in 1990 was more that 482,000 persons. According to the GAO, Texas lost roughly \$1 billion in federal funding during the 1990s as a result of the under count. The undercount in Texas was the second highest in the nation. In the greater Dallas area an estimated 40 percent of us did not respond to the Census in 1990!

Why is obtaining an accurate count so difficult? The answer lies in the complexity involved in completing a Census and the size and diversity of the population. In Texas, 32 local Census offices will operate with an estimated 45,000 employees during the most intense part of the work. An estimated 7.4 million Census questionnaires will be mailed in Texas alone, during the first part of March 2000 with follow-up and other efforts continuing through fall 2000.

We all know that there is growing cynicism relating to telephone inquiries and questionnaires. PLEASE take the time to respond to the Census 2000 questionnaire. The specific information about you and your family is held in the strictness confidentiality, and by law can not be released for approximately 70 years. Let us all ensure that we are part of the statistics and are counted. For once, we can all be part of the solution.

#### Property Tax Exemption By Bill Johnson

Recently, the Garland City Council approved a \$5,000 increase in the homestead exemption available to senior citizens and disabled homeowners. The increase will put this exemption value at \$51,000, as was discussed in a recent Garland News article.

Intrigued, I dug out my last city tax statement to verify that I was receiving this exemption from my city taxes. Lo and behold, I was not! A phone call or two revealed that this is an additional exemption to the standard homestead that most of us have. But, one must apply for it when one turns 65 years old (or when one qualifies as disabled). Having a standard homestead exemption does NOT automatically sign one up for this exemption.

Since I am now a senior (old gomer, old coot, etc) and eligible for this exemption, I called the Dallas Central Appraisal District (214-631-0910), asking for a Residential Homestead Exemption Application form. This form allowed me to request the senior/disability exemption, and to apply it retroactively up to one year. I wonder if there are others in our community who, like me, are eligible for this tax reduction but are failing to claim it. If so, you now have the number to call. Go for it!

#### Open Garages By Bill Johnson, C.O.P. Coordinator

We've mentioned this before, but in the Police beat section of the Garland News on Sunday, March 5, the GPD Neighborhood Police Officer Unit reports they are encouraging homeowners to keep their garage doors closed, after a rash of burglaries. In 1999, more than 200 of the 1292 habitation burglaries occurred when the homeowner left the garage door open. Officers are leaving fliers at homes where they find open garage doors, reminding people to properly secure their homes. The most stolen items are bicycles, golf clubs, and lawn equipment.

The GHC has discussed what they consider the three or four most important issues we would like brought before the State Legislature when they convene in 2001. These issues will be prioritized by TNT (Texas Neighborhoods Together) and used as they form a Legislative agenda to be introduce in 2001. The following are GHC suggested list to be provided to TNT:

<u>Municipal Authority.</u> The State continues to whittle away at established Municipal authority. The cities should have the right to regulate such things as alcohol sales in restaurants, amortize undesirable uses and zoning authority without State intervention.

<u>Code Enforcement.</u> Improve the cities ability to enforce its health, safety, and nuisance ordinances.

<u>Traffic Control.</u> Grant municipalities the authority to implement a photographic traffic control system.

<u>Car Insurance Control.</u> Develop a common data base with DMV and all automobile insurance companies that would raise a red flag if car owners do not insure their car or cancel their insurance. This could lead to automatic removal of their divers license and car registration.

# <u>Neighborhood Traffic Control Program</u> Reprinted with permission from the Garland Homeowners Coalition Newsletter

The City of Garland instituted a Neighborhood Traffic Control Program in 1995. This program provides the necessary ground rules for citizens to request all-way stops or speed bumps to slow traffic or to discourage cut-through traffic on residential streets. The policy is designed to provide reasonable opportunities for the installation of all-way stops on specified types of residential streets based upon the degree of support from the surrounding residents and street conditions.

The degree of residential support is a major factor in the consideration of all-way stops or speed bumps. A survey of the homes within a specified survey area must be submitted to the city demonstrating the required degree of resident support. All homes within a specified distance whose front or side yard adjoins the street on which the new sign is being requested shall be included. At least 80% of the homes in the survey area must indicate support of the installation. A uniform fee for installation will be based on the actual cost for the installation. The neighborhood requesting the installation will be responsible for collecting and submitting the required payment to the city.

Not Certified by the Texas Board of Legal Specialization The following February 9, 2000, letter was written to the city manager of Garland by James M. Parks, Executive Director of the North Texas Municipal Water District. (Garland obtains all of its water from that district. The letter pertains to a recent Sixty Minutes story on the possibility of a certain gasoline additive contaminating water supplies and is a response to the many calls from local citizens the District has had concerning the story.

#### NORTH TEXAS MUNICIPAL WATER DISTRICT

On Sunday, January 23, 2000, Sixty Minutes presented a story on methyl tertlary butyl ether (MtBE), a gasoline additive. If you recall, a similar story was aired in September on Channel 8 News, because of which we sent you a fact letter. We have had many calls from concerned citizens about this report, and we would remind you of the following facts on M113E:

Additional tests on NTMWD raw and finished water continue to show no detectable concentrations of MtBE. We will continue this testing on a quarterly basis.

MtBE is a gasoline additive that has been used since 1995 in air quality non- attainment areas. It promotes clean burning of gasoline and thus reduces ozone levels in the atmosphere.

MtBE has been shown to be carcinogenic to mice when inhaled in large concentrations. Further studies are underway, Therefore, EPA has "tentatively classified MtBE as a possible human carcinogen.

There is not currently a maximum contaminant level (MCA) established for MtBE in drinking water,

but the EPA recommends that concentrations not exceed 2040 ppb.

MtBE can reach high concentrations in groundwater because it can easily enter an aquifer through leaking underground fuel storage tanks at filling stations and does not volatilize (evaporate) underground,

MtBE can be introduced into a lake through storm water runoff from urban areas and gasoline spills from motor-watercraft; however, since it is volatile, it does not remain in surface water for more than a few days depending on temperature and wind effects, and therefore, is unlikely to reach measurable concentrations at the water plant intake.

Mr. Parks said that if the city manager or any of his citizens have further questions on the subject gasoline additive, they should contact Denise Hickey, Dolan McKnight or him Their address is North Texas Municipal Water District, 505 E.
