Thoughts from City Hall

I have read with interest the stories and indictments emanating from Dallas City Hall where it is alleged that

certain Council members and Plan Commission members took bribes from a low cost apartment builder, so he could get the contract to build in the City of Dallas. My immediate question was how just a couple of members of the large Dallas City Council could have that much influence. If, for example, the City of Garland were involved in having some low cost apartments built (and we are not!!), sealed bids would be sent to City staff who would evaluate them. Then, staff would present to the entire council a list of bidders including their bid amount, and the entire Council

would select the winning bid. This is generally the lowest bid. So, a single Garland council member could theoretically be offered a bribe (ala the allegations in Dallas), but that's just one vote when it comes time to award the bid. Of course, to my knowledge, a Garland City Council representative has never taken a bribe.

So, how does this work in Dallas? After all, Dallas and Garland both have a Council/City Manager form of government. Apparently, in Dallas, each Council district is basically a little fiefdom where, if a project is to be developed in a Council representative's district, the council member in conjunction with the Plan Commission representative

The Other CPA Corner: Estates, Trusts, and Gifts, Part 1

This is perhaps the most confusing and misunderstood area of taxation.

Yes, that is saying a lot when talking about things IRS. My opinion is that this tax is government greed in action since.

 The net assets owned by an individual at the date of death, less certain deductions and exemptions, are subjected to State and Federal taxation. Again, this is

not a tax on income – it is a tax on the assets of the estate as modified.

 ot 2. Following

in some cases, it taxes wealth that has previously been subjected to income taxation and even estate taxation. But, it exists and we have to deal with it. Let's take a moment and learn some basics that will help simplify things. What I say below is in generalities as there are many exceptions that are applicable and available.

this tax on net assets owned at the date of death, the estate lives on as if it were an individual person. There is a Federal income tax return due on earnings that those assets generate after the date of death until those estate assets are completely distributed to the trust and/or individual beneficiaries.

3. There is a Federal tax return due for any taxable gifts given by a taxpayer. In addition, if a spouse has given a "split" gift from jointly owned assets, that other spouse will need to file a separate Federal gift tax return as well - there is no such thing as a "joint" gift tax return. Currently, each person can give away \$12,000 to an individual recipient in 2007 without a gift tax being imposed on the person making the gift. For example, a husband and wife could give, tax-free, to each of their children a combined \$24,000 each in a single year for 2007 -\$12,000 from the husband to the child and \$12,000 from the wife to the child. If the child is married, an additional \$24,000

can approve any contractor's bid without any staff oversight and without any review by other Council members. Wow! Just amazing.

On October 4, James Ragland wrote an article in the Dallas Morning News explaining all this. Although I agreed with many of his remedial suggestions, I certainly disagreed with one and fired off the below letter to the editor. As of this writing (on October 8), the letter had not been published, and it may or may not be at a future date. I will say that as a group, I am very proud of the other 8 council members with whom I work. Sure. we do not agree on all issues, but we all have the same goal of working together honestly with Garland's

best interest being our single purpose.

Re: "Council needs a good watchdog," Thursday Metro

Mr. Ragland provided several suggestions to reduce corruption among Dallas City Council representatives, and I certainly agree with most of them such as far more internal oversight of this legislative body. However, his suggestion that increasing the salary of \$37,500 per year might reduce the temptation to take money under the table is without merit. There is nothing to suggest that corruption decreases as legislative salaries increase as

evinced by the fact that U.S. House and Senate representatives earn \$165,200 per year. Rather than increasing Dallas Council salaries, I'd suggest decreasing salaries, say to the salary level of Council members in Garland (the 10th largest city in Texas) of \$400 per month!

A salary of \$400 per month eliminates any financial incentive to run for council and attracts only those candidates who chose to serve for the right reason—public service. When's the last time you read about an elected Garland official involved in financial scandal related to city business? Don't waste your time researching the question.
