Council 7 Update

I'm one of those people who occasionally writes letters to the editor of the *Dallas Morning News*. "Inspired" by recent scandals in other cities, I wrote the below letter to the DMN published on March 9:

Re: "Office budget busted -- Neumann overspends by \$8,000, annoying more frugal members" and "Inquiry to focus on officials' trips -- Full-scale internal probe promised of pricey N.Y. travels," *Feb. 28 Metro.*

"What you don't read about Garland are stories like the one in Saturday's Metro section regarding Mesquite council members taking lavish trips at taxpayer expense. What you don't read about Garland are stories like the one in Saturday's Metro section regarding a council member in Dallas

far exceeding his \$16,400 office budget. The eight Garland City Council representatives don't have an office budget or an office. What you don't read about Garland are articles frequently appearing in the Metro section where a local municipality has "suddenly" discovered a huge budget shortfall -- and now drastic cuts will be necessary. Garland's managing director of budget and research does not let surprises happen. What you don't read about Garland are stories of internal bickering and petty jealousy. What you don't read about Garland are stories of credit card abuse a la DISD. In sum, Garland citizens have a right to be proud of their city and how it is run."

Engineering & Operations Technical Conference in Austin, Texas.

The deadline for filing for the May 9 election has passed, and I did not draw an opponent in District 7. In fact, the council representatives in Districts 3, 6, 8 also did not draw an opponent. The Mayor does have two opponents for the May 9 election. Someone asked me how much an election costs the City of Garland and it varies depending on how many other entities (cities, counties, school districts) are also having an election. There's a large fixed cost incurred by the Dallas County Election office during an election, and the fixed cost is essentially divided among the locations holding the election. For the May 9 election, the cost for Garland is \$46,723.39. If there happened to be a run-off election for Mayor, the cost of the run-off would be higher as there would be fewer entities to divide the cost. For example, the run-off election in 2007 between Ron Jones and Lee Alewine in 2007 was over \$100,000.

I may have mentioned this before, but it's worth repeating. For some elderly or disabled individuals, moving the large green trash containers for pick up can be very difficult. If that applies to you or someone you know, there's a form which can be completed and submitted to Environmental Waste Services. If approved, EWS personnel will retrieve the container on trash day, empty it into the truck, and return it.

On March 9, the Council attended a water and waste water briefing conducted by a consultant who does work for many municipalities in the DFW area. His bottom line in the 1 $\frac{1}{2}$ presentation is that in the next 5 to 10 years, the cost of water and waste water will likely be rising at a faster rate (perhaps 5 to 6% per year) than inflation. This was not a televised presentation, and we requested that this presentation be repeated in a council work session so all can see it.

You may have heard, read, or seen some confusing reports about Garland's safelight program toward the end of March. A story in the March 24 edition of the *Houston Chronicle* said that Garland had "lost" \$350,000 in fiscal year 2008. L. P. Phillips with KRLD called me, and I did a recorded radio interview on the story. WFAA television also did a short blurb again saying Garland "lost" \$350,000. Then in March, the amount was \$0. Confused? You should be. The truth is that Garland has a contract with an organization that installs and maintains red light cameras. The contract calls for them to make a certain amount of money each month, and if they make more than that, this profit goes to Garland and we have to give half of that profit to the State. Garland uses any profit only for public safety purposes. But, if the cameras earn less than the contracted amount, that deficit is NOT made up by tax dollars. It is just a deficit amount that can be paid to the contractor only by future amounts collected by the red light program. The \$350,000 amount may have been correct for FY 08 since we had shut down several intersections and were waiting on TxDOT to approve some intersections; however, Garland did not "lose" that money. The bottom line is that Garland's safelight program is designed to be pretty much cost neutral while improving public safety. Those who scream that it is a subversive money-making scheme by the City to make money do not know what they are talking about, but it never stops them from talking.

The Trammell Crow mixed use development and the Richland College campus (both near Walnut and 5th Street) are both rapidly nearing completion. Further, this Transit Oriented Development project has been selected to be one of only four projects showcased at a workshop presented by the Urban Land Institute (ULI) on April 2nd in Dallas. ULI is a nonprofit education and research organization with over 40,000 members worldwide whose mission is "to provide leadership in the responsible use of land and in creating and sustaining thriving communities." Their membership is made up of development professionals, business and civic leaders and urban planners. It's an honor for Garland's project to be selected for this presentation.

I reported in last month's article that we were debating the placement of green trash containers, and we did have a lively debate on that subject in March. We sent the issue to the Citizens Environmental and Neighborhood Advisory Committee for their input, but it will be coming back to Council for further discussion. Stay tuned.
