On May 23rd, I was sworn in at City Hall for my third and last 2-year term as the District 7 City Council representative. The City Charter puts a limit of 3 consecutive 2-year terms. Two new council members were sworn in (Lori Dotson for District 6 and Jim Cahill for District 8). During my first 4 years on Council, we as a group have worked well together avoiding some of the well-documented problems of past councils. I am

confident Lori and Jim will continue with this collegial working relationship.

Pawsabilities is a dog rescue organization that works closely with Garland Animal Services to help get dogs adopted. I recently attended a fund raiser at Ozonas restaurant on Greenville sponsored by Pabst Blue Ribbon beer in con-

survey was being done using a secure professional program called [SurveyMonkey.com](https://www.surveymonkey.com). This Survey is was done as a cooperative effort between ONA members and non ONA members to help develop data to assist future buyers of the club. There were 135 responses and the survey data is displayed as written and has not been altered.

Pat Searight, the program development manager for Landscape Unlimited was overseeing a mechanic to repair the pump. You may remember that Landscape Unlimited is maintaining the golf course to a park like setting. Pat said that he is amazed but he says the greens appear to be coming back. Unfortunately, he said they are not equipped or authorized to maintain the greens in the way required to further encourage their growth.

This information may change by the time you get this newsletter but it appears that there are 4 companies interested in the purchase of the club. This was announced by Larry Walters at the ONA General meeting on May 19th.

Participation:

In plotting the membership of the ONA per street it appears that Lone Oaks Trail has the highest membership and Richland has the lowest.

Table 1 shows the percent membership per street.

There are a number of reasons people will not join but none of them make any sense. If you simply do not like the way the ONA operates then run for office and fix it. Communications:

Keith Engler will not return as the communications director in order to pursue other volunteer opportunities. Dana Hopkins has volunteered to take over the newsletter. Keith will continue with the website for now. Of course, both of these positions have to be nominated by the President and approved by the board per the Bylaws.

Keith purchased www.OakridgeNA.org and www.OakridgeNA.net and has been hosting them for the last year. The previous hosting company lost our original “.com” domain, which is a long story. In planning for the next person to take over the website, Keith purchased space for four years using JusHost.com. It is still under his name but it is ready to be handed off to a new website administrator.

Keith setup the website recently to take PayPal for ONA dues and optional beautification funds.

Environmental:

As of June 1, 2011 the ONA will have a new lawn maintenance provider; QUALICARE, a full service landscaping and Maintenance Company was the successful bidder. QUALICARE has been in the landscaping and lawn maintenance business for a number of years, and as a professional landscaping business will be able to advise the ONA on what is needed to keep our neighborhood beautiful. The first thing we will be working on is planting the flower beds with summer flowers, they defiantly need some work. After the planting is completed we will assess our future needs both in upgrading and maintaining the existing landscaping.

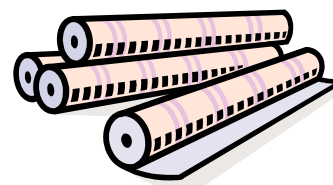

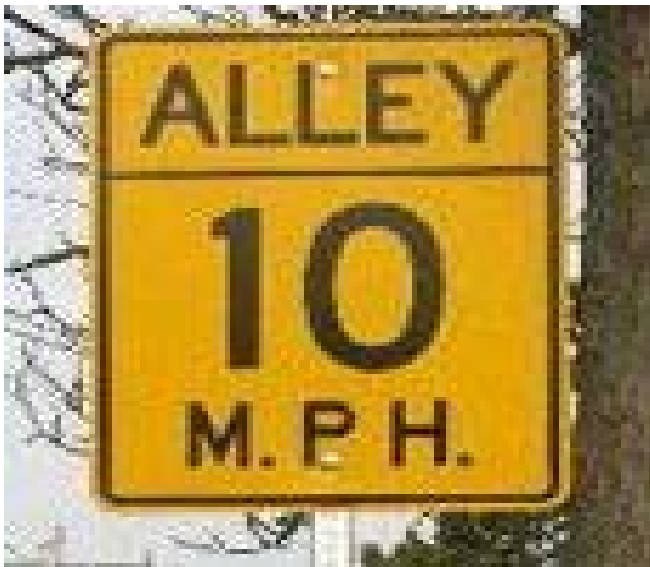
Garland city officials have declared **Stage 1 Drought** Response measures in effect, beginning April 19, 2011. Under Stage 1, the City will increase education efforts to reduce water use, and urge residents to detect and repair water leaks around the house. Garland residents are requested to voluntarily practice water conservation, minimize or discontinue water use for non-essential purposes, and voluntarily follow the designated landscape watering schedule:

- Even-numbered street addresses water on Sundays and Thursdays
- Odd-numbered street addresses water on Saturdays and Wednesdays
- Town homes and businesses having a common irrigation system water on Mondays and Fridays
- Apartments use the address of the business office for the property

Being a good neighbor:

The mission of the ONA is not to impose code violations or tell people what they can or cannot do. Each citizen has the right to call about code violations. The speed limit in the alley is 10 MPH. I intuitively felt that I was driving safely in the alley until I started paying closer attention. I found that my truck naturally rolls at 10 MPH so if I am accelerating at all then I am driving too fast.



The speed limit on the streets is 30 MPH which is reasonable but many go faster than that. These streets cannot support even 35 MPH. Please just ask yourself if you are driving at a safe enough speed to stop if a child or animal runs out in front of you. Plan your time better and don't try to make up your lateness in the alley or street.

Also consider our neighbors on the golf course. Granted, the golf course is posted but if you do walk on the course then try not to get too close to the backs of the neighbors property line and try not to disturb their dogs. The dogs are not used to people in their backyard especially since they do not have a steady stream of golfers anymore. Therefore, they have a tendency to run and bark and cause damage to their flower beds and shrubs.

A proactive neighbor's idea:

"The beautification program that took place a year or so ago resulted in planting a lot of shrubs, trees, crepe myrtles along the border streets such as Shiloh and Buckingham.

They now look awful as they are not being trimmed properly, and per our last newsletter we are supposed to be making the property look good for the hopeful sale of the golf course.

So....I propose an "adopt a bush" program where residents take responsibility to trim one, two or three of these bushes regularly and keep them looking good. Maybe we could get someone to give us a lesson. So who do I write to with this suggestion. How much trouble is it to trim one bush?"

This ONA has hired a new landscape company who is starting in June. This new company is a professional company run by a certified landscaper. This issue is known and being addressed with them. Hopefully, we will see improvements in the upcoming months.

Oakridge is still Desirable *by Peggy Richie*

First of all, I would like to thank the person who is keeping us updated about the foreclosed country club. Perhaps my personal opinion will make you feel better and here are my thoughts on the subject:

I would like us to re-think the values in our neighborhood. Right now the golf course looks like a greenbelt or a park. Because it is in the flood plain it will remain land. I still feel for those of us who live on the "golf course" it is still prettier than backing up to an alley and someone else's eight foot fence. People who know nothing about the golf course love my view when they come to visit. It sounds to me as if the receivership company is taking steps to maintain the land.

Although it is not maintained at the level of a park, with the trees and the creek it looks like one. The fact that they are going to mow the property helps and the only bad areas are the ponds that have no water. Perhaps in time we can get the receivership company to change that. I was told that the two pumps used to pump water from the creek had burned up due to lack of oil and they are 50K a piece. Then I heard that the old club owner had not paid the city the necessary fees to pump water out of the creek. Regardless of the reason filling the ponds would help, but we have no control over that.

I was also informed that two of the single greens are above the flood plain and homes could be built on them using the street entrance as a cul-de-sac type project. First of all, before that can be done, a variance has to be approved by the city. The entire neighborhood will be notified if this type of meeting takes place and at that time we can speak at the planning commission meeting and bring up several points such as having paid a higher purchase price and taxes for our properties because of the golf course and the view. This type of development would certainly hurt our values and a park would certainly be equal to a golf course.

I have not spoken to an attorney, but I am guessing that there could be cause for a class action suit. I don't think the city wants 1000 people at their meeting opposing the variance and wanting

to be paid for their loss and refunds on prior taxes paid. Just remember, the city is currently on our side. They want us to be a golf course.

At any rate, keeping our exteriors beautiful so a buyer wants to own a golf course in the middle of our development will help. Let others know that the foreclosed golf course is being maintained and they are diligently looking for a new owner. Let them know we still have a nice view, custom homes, pretty entries and a great location. This will help distill negative public opinion that our property prices are ruined. I am hearing this from people outside the neighborhood so we need to quit fueling the fire.

I am currently selling my home to downsize and hoping to move to a patio home on the other side of the course. This is my neighborhood too. I have been here since 1990 and joined the club in 1987. I have seen many owners and many situations with the country club. I feel that given time...this will get resolved too.

junction with Pawsabilities. I bought \$20 worth of raffle tickets, enjoyed very good margaritas and nachos, and to make things even better, I got a call from a PBR representative the next day telling me that after I left, I won a \$50 certificate for Luna de Noche restaurant. More significantly, he said this event raised over \$6,000 for Pawsabilities, and 6 dogs (which were at Ozonas) were adopted. It was all good.

In my March article, I wrote that Garland Animal Services had recently announced a cat adoption partnership with PetSmart Charities whereby cats from the Garland Animal Shelter would be provided to the new PetSmart store in Wylie, 3340 FM 544. Animal Services staff has recently reported that the cat adoption program has gone much better than expected, and euthanasia of adoptable cats has almost ceased.

On May 19, the City of Garland received preliminary property appraisal values from the Dallas Central Appraisal District (DCAD). We are pro-

jecting a 3.5% decline in Garland's property tax base which follows declines of 3.5% in 2010 and 3.7% in 2009. New construction values are being reported to be \$51 million, the lowest levels since the City started keeping records in 1988. In total, the City is projecting a deficit of \$3.5 million (2.6%) in the General Fund for 2011-12, so the budget discussions in September and subsequent passage of the FY 12 budget will be difficult.

No doubt you have seen the recent local TV news stories about the IN-N-OUT hamburger restaurants opening in McKinney and Allen with people standing in line for up to 2 hours. We have already approved the zoning for such a restaurant in the Firewheel Town Center, and the latest I hear is that it should open in early 2012.

Handyman Tips *by Keith Engler*

I am not a roofer and typically do not get on roofs, but I have been on a few lately. All homes are required to have sewage vent stacks which extend through the roof. My house has lead vent stacks but many others in Oakridge have rubber boots like the one in the picture.



It seems that the rubber boots tend to deteriorate in approximately 5 years which leaves a hole in your roof. My lead stacks are not safe because squirrels like to sharpen their teeth on the lead.

It would be a good idea to have your stacks inspected before they deteriorate to the point where you get water damage inside your house. You can expect to pay from \$40-50 per vent stack to replace them.

This work should be done by an experienced roofer because shingles can get damaged during the replacement process. This is not the kind of work that I do with Sir Fixalot; I am just passing on the observation.

find suitable day care for their children with disabilities. Beginning with a dream and \$800 raised from a parking lot sale, this group formed their own day care center. The Reverend Michael Haynes, father of a child with disabilities, offered this group the use of the Sunday School building of the St. Paul United Methodist Church. The center was housed at St. Paul's for 16 years.

Then after 23 years in service and a student population of 65, the Achievement Center faced needing more space and began a campaign to build a home of their own. With donations of money and land, the Achievement Center of Texas moved into its new facility at 2950 North Shiloh Road in Garland on February 3, 2003. Now, after celebrating their 30th birthday on October 12th, 2007, the Achievement Center currently serves 140 students daily.

Stop your mail and have someone pick up the newspaper each day (we advise you to not call the newspaper company because you are put on a list of "people out of town"). Ask children not announce to the whole school your vacation plans.

The weather is now just right for our beloved "magazine sales" and "environmental survey" types to be in our neighborhood, knocking on doors. Be aware of these individuals, don't open doors and never let someone you don't know inside your home. Everyone who is soliciting in Garland, with the exception of Boy and Girl Scouts, Verizon, Church Groups or Politicians must have a Garland Permit. If someone does have such an ID hanging around their neck or on a clip where it is clearly visible, you will know that the individual has already been checked out by the Garland Police Department and may be "safe" to talk to.
