City Council by Rick Williams

I mentioned in last month's article that the city was anticipating a \$3.5 million dollar deficit for fiscal year 2012 (i.e., Oct 2011-Sept 2012). Since we have been trimming the budget the last several years and doing other cost-cutting measures, the options for dealing with the FY 12 shortfall are very limited. In light of this challenge and the City Manager's desire to propose a balanced budget with no tax rate increase to the Council, he has decided to go forward with an early retirement incentive program for non-civil service employees (i.e., basically, all city employees other than police and fire). The retirement incentive closely resembles the programs being offered by GISD and other Metroplex school districts (e.g., a lump sum payment based on longevity up to \$10,000, etc. for those who retire early). Although I personally appreciate the City Man-


ager's desire to present (in September this year) the Council a proposed no tax increase budget for FY 12, I do get concerned about the impact of city services if significant staff loses are incurred. As I have said many times in the past, for every 100 complaints I receive, one is about taxes and 99 are about city services. We will discuss the City Manager's proposed FY 12 budget in September, and it should be "interesting."

Budget will also preclude Garland hosting the "Star Spangled 4th of July Celebration." In the last couple of years, the Firewheel Town Center has hosted a fireworks display with some help from the City, but not this year. Firewheel Town Center will be hosting a scaled down event on Saturday, July 2. The event will be held from noon to

Stage 1 Drought in Effect

Garland city officials have declared Stage 1 Drought Response measures in effect, beginning April 19, 2011. Under Stage 1, the City will increase education efforts to reduce water use, and urge residents to detect and repair water leaks around the house. Garland residents are requested to voluntarily practice water conser-

vation, minimize or discontinue water use for nonessential purposes, and voluntarily follow the designated landscape watering schedule:



- Even-numbered street addresses water on Sundays and Thursdays

- Odd-numbered street addresses water on Saturdays and Wednesdays

- Town homes and businesses having a common irrigation system water on Mondays and Fridays

- Apartments use the address of the business office for the property

The implementation of Stage 1 comes at the request of the North Texas Municipal Water District (NTMWD), the city's water supplier. NTMWD initiated the Stage 1 of the NTMWD Water Conservation and Drought Contingency and Water Emergency Response Plan, March 2008, because as a result of invasive zebra mussels being found in Lake Texoma and the temporary loss of the Lake Texoma raw water supply by NTMWD.

In August 2009, the Texas Parks and Wildlife

Department discovered zebra mussels in Sister Grove Creek, a tributary of the East Fork of the Trinity River and used by the NTMWD to transfer water from Lake Texoma. As a result, NTMWD voluntarily ceased pumping raw water supplies from Lake Texoma and has not resumed pumping. The infestation of zebra mussels in Lake Texoma has resulted in a loss of 22.5% of the NTMWD's total raw water supply. At this point, NTMWD does not have a firm date for the resumption of pumping from Lake Texoma, however, NTMWD will continue to collaborate with the federal and state agencies to hopefully resume pumping in latter 2011.

While zebra mussels are not harmful to humans, they do attach to water facilities and pipes causing millions of dollars in maintenance costs. NTMWD has and will continue to collaborate with federal and state regulatory agencies to develop a strategy to minimize the transport of zebra mussels into the Trinity River basin.

"This is a complex environmental and conservation issue," said Parks. "It is the first time zebra mussels have been found in Texas and NTMWD is the only water supplier transferring water from Lake Texoma to the Trinity River basin. That's why water conservation efforts are so important.

We are working on a solution so this does not become a bigger issue for other water sources in the state."

NTMWD officials are working closely with state and federal agencies on possible solutions for zebra mussels, which were first discovered in North America near the Great Lakes in 1988. Zebra mussels are typically transferred from one river basin to another by boaters and anglers.

Garland has about 1,000 miles of sewer lines. received a question as to whether we ever check sewer lines for leaks and blockages. Staff says they cleaned and/or checked by camera 186 miles of sewer lines in 2010. Leaks into the sewer system increase the volume of waste that must be cleaned by the sewer treatment plant, so it's to the financial advantage of the city to find and fix leaks. This sewer blockage question was generated due a concern about back-ups created by a blockage in the city's sewer system and who would be responsible for the cost of cleaning up the damage from a backed-up sewer line. Regarding the City responsibility, it falls into the category of municipal immunity. Basically, if cities were not immune, they would get sued for just about everything. In this case, as a government Garland owns and operates the sewer system, but we can't control what people dump into the sewer system, we can't control to get weather warnings sent to your cell or land tree roots, shifting soils, etc., so the State limits municipal liability. However, in the vast majority of back-ups, blockages are found in the customers' sewer line. If there is a concern about sewer back-ups, check with your insurance provider.

Because the State legislators did not ban these substances, the Garland Council is now considering an ordinance to ban it in Garland.

We recently were briefed on a proposal by GGI Energy and Automatic Products Corp. They

want to partner with the City of Garland to develop three, pollution free, waste-to-energy facilities at our landfill and waste treatment facility. Under the proposal, we would provide the waste at no cost to GGI Energy, and GGI Energy would build and operate these facilities at no cost to the City. By diverting about 20% of our waste, this would save the City \$1.3 million dollars in landfill operating cost, it would increase our property tax revenue by about \$400,000, and it would create 255 new jobs in Garland with an annual payroll of \$13 million. Discussion details with the City are ongoing, but so far, it looks like a win-win proposal.

During a June 20 work session, we discussed outdoor warning sirens in Garland. Currently only 3 of 19 work, and I believe they should all be shut down. Sirens are for outdoor warning only, and with cell phones and so many other options for getting weather warnings, it makes no sense to me to spend about one million dollars to cover the entire city with an operable warning system. However, the Council voted 8 -1 (I was the "1") to get more information. As I have mentioned in previous articles, if you want line phone, go the Garland's home page www.ci.garland.tx.us and click the "Code Red" box. Note that if you are signed up for Code Red currently, you will not get weather alerts unless you specifically sign up for the weather warning feature within Code Red.

The membership entrance signs are on display and membership flags are being posted at each home when you join us this year.

We are underway with our annual membership drive and we are looking for that magic number of 500. We have been so close to achieving our member goal with last year's total coming in at 484 members. Let's make 2011 the year we tip the 500 member goal.....

Oakridge has 1166 homes in the neighborhood. In order to achieve our 500 member goal we need 43% of Oakridge residents to join the Oakridge Neighborhood Association. An Update on the Country Club

We're certain every resident of Oakridge is anxious to know what's happening with the Country Club and we've got some answers.

From the beginning, the lack of an operational sprinkler system was a major concern for both the bank and the maintenance company. To begin to alleviate this problem, the main pump needed repair. Once that repair was completed it became evident there were broken or damaged pipes scattered around the course. After those were repaired or replaced still another problem arose because some of the controllers weren't working. Those were also repaired—and now, finally, after a lot of work by a diligent maintenance crew, the sprinkler system is working again! Unbelievably, right in the middle of all this, the roof on the pump house was severely damaged during one of the recent storms. Without repair, rain water could have readily entered and damaged the pump, however, instead of an ugly patch, a new roof was installed and this should protect the pump for many years to come.

Diseased, old, dead and damaged trees scattered around the course are being removed. Tall weeds along the creek areas are being cut to allow a free flow of the water during storms, but every effort is being made to protect the ducks and other wildlife in or near the creek. The lawn around the clubhouse has been and will continue to be cut and <u>edged</u>.

All of the actions listed above have helped the entire country club area look better than it has in quite awhile. The course itself looks greener, but of course, the recent, perfectly timed, rains have helped tremendously. Some of this is also attributable to the way in which it's being mowed. Normally a golf course is cut pretty short, but currently the grass is being cut at a longer length. This helps provide shade to the roots and helps the grass grow thicker and greener, even without any fertilizer being applied. There has been no fertilizer or weed control applied to the course during the past year--- just imagine how great it would look with a good shot of fertilizer! Another

bit of good news, Pat, from the maintenance company, told me last week that he is seeing grass beginning to grow back on some of the damaged greens. Although most of the greens will still need to be seeded and allowed to grow before they are playable we've learned there is a new method of seeding that considerably reduces the amount of growing time. In the past, it took a lot of preparation of the soil and at least 90 days for the seeds to come up, grow to the proper thickness and length before it could be utilized. This new method apparently works fully in approximately 90 days from start to finish and doesn't require as much preparation of the soil. Based on that timeline, if someone purchases the club and starts immediately working on the greens, the course could possibly be ready for play in mid-October. Wouldn't that be great?

As a point of information, we want to let you know the Hillcrest Bank signed an agreement a couple of days ago authorizing a landscaping company to prune the bushes along Jupiter and Beltline. The bushes have become so overgrown that some branches are protruding into the right traffic lane along Beltline. The pruning should begin soon, so we should anticipate the closure of at least one lane between Beltline and Laurel Oaks in the near future.

Hillcrest Bank has expended a great deal of money to ensure the Country Club and its surroundings are attractive to prospective buyers. Their representative has advised us that the listing broker anticipates 5 different offers will be coming in within the next 30-45 days. At the same time we learned that some of these prospects have already brought in various types of contractors to obtain estimates for the necessary repairs or replacements, and these individuals seem highly motivated as well as financially stable.

Monday, June 20th the nets on the tennis courts were removed and placed in storage in an effort to protect the surface of the courts from further damage. They had become an "attractive nuisance" and were encouraging individuals from outside Oakridge to make use of the courts for purposes other than tennis. While the courts aren't in perfect condition right now, they are still in playable condition. This action may help delay an expenditure of approximately \$85,000 for resurfacing the courts and thereby encourage a new owner.

One other bit of good news is the information verified by the bank just today (21st). The Shores Country Club in Rowlett was sold and the final papers were received by the bank over two weeks ago. Apparently there is still some work going on at that club and it isn't ready for play just yet. We do believe this is another sign that there are buyers out there; the marketing company

In mid-June we were contacted by a couple of residents in the duplex area concerning a man going door to door selling security systems. Since we had a confrontation with this kind of salesman a couple of years ago we didn't bother to ask him questions but rather called police. Garland police came out and had a "chat" with the man, told him to leave Oakridge and get a soliciting permit. This young man was asking questions of homeowners like "Do you have a security system?", "Is your system digital or monitored?", "We have GE systems". We checked with the police department permit unit the next day and learned no one from GE systems has applied for a permit. If anyone comes to your home selling security systems it's our advice that you tell them to go away. If they are persistent, close the door and call 911. If you call us also, we can shadow the individual until police arrive so they know just where to find the person.


