District 7 City Council Scott LeMay

Hopefully by the time you read this our usually excellent bulk trash and brush removal is back on schedule. It goes without saying that the ice storm in early December had a huge impact on our service delivery and stretched our resources. In early January we received an excellent update from Managing Director of Solid Waste Services, Lonnie Banks. Just to try to summarize we have never had an event similar to this. Yes we have had ice storms and yes we have had tree damage from storms. Rarely does a weather event like this occur where the entire city is impacted to this degree. Our Solid Waste crews worked 7 day weeks and we pulled in employees from our Streets and Utilities Departments to assist.

Citywide for December 2012 our Bulk and Brush crews removed a little over 3000 tons of material. For December 2013 they removed a little over 6000 tons. The council will receive a recap of this event in late February or early March and I will report those results.

Council Updates-

As we enter the New Year it is time to review our Capital Improvements (CIP) budget for 2014. We were presented the proposed budget at our first meeting in January to begin the review process. This budget represents ongoing projects from Bond Elections as well as improvements to facilities and equipment. We will have several Work Session discussions on this as well as public hearings. Our projected date for adoption is February 4th.

Once that is complete we will begin the process of reviewing our new Garland Development Code (GDC). In a nutshell we are updating the development codes for the entire city. Some of which have been in place since the 1950's. Obviously many changes have occurred in Garland since then and those documents have been amended many times. Our goal is to create a set of development codes that will encourage new development and make redevelopment easier. Our current development codes are really designed for "green fields" that have never been built upon. With our almost complete build out this type is really not what our focus needs to be on anymore. We have more areas in need of redevelopment than I could ever list here. We need to make much more of an effort on those areas and the last thing we want to do is have our own outdated standards standing in the way. We will be holding weekly joint meetings with our Plan Commission on this starting February 13th. Those meetings are scheduled all the way through the end of March and we welcome your input and observations.

In one case the subject asked to use the homeowner's bathroom. Our NPO has requested that instances like this be reported to police via a 911 call. Also a group is calling seniors telling them of their winning "Publisher's Clearing House contest. They will ask you to go to a nearby CVS store to get two \$500 money "green dot" cards which they will collect later. Also, they want your bank account #.

These guys are very convincing salespeople. The best thing to do in this case is to call the police 972-485-4840 and ask for a CID fraud investigator. You may wish to contact credit reporting agencies and your bank. The most recent incident occurred on about Jan 18, 2014.

Oakridge has had a decrease in crime with around 45 incidents for the 2013 year compared to over 75 for 2012. A great majority of these 2014 reported crimes are minor in nature. No crime involved violence toward any resident. This drop can be attributed to neighbors being more watchful, growth of the NPO unit, and better communication between our COP group, police, and homeowners. Oakridge-ites keep up the good work!!!!!!!
