#### Neighborhoods Need the Strength of Community-Mayor Douglas Athas

There is a word for when the whole is greater than all the parts added together: synergy. When neighbors work together, they accomplish many things that they wouldn't be able to do if each worked on the task individually. Neighborhood associations make neighborhoods stronger, more able to identify and address challenges, to seek solutions that work for the neighborhood, that get attention from city officials, that mobilize city services.

That is true only if the association is active.

Over the last couple decades, neighborhood associations have been instrumental in some of the major changes realized in Garland. The Neighborhood Vitality program and grants can be traced to discussions and action by neighborhood groups. Those grants have led to screening wall replacements, neighborhood entrance improvements, beautification projects, meeting pavilions, and much more.

Neighborhood associations and the links between them have kept a check on bad government, including countering the effort in 2006 by some council members to cancel elections and just stay in office another year. The fight to support the city charter and to follow the law originated en-

tirely with individuals linked by their involvement with neighborhood associations.

Many association leaders become members of city boards and commissions. Many become council members and mayor, such as now with Councilman LeMay and myself, but also others serving on the council now and in the past.

Virtually the entire city council and city staff are working to "Grow Garland." There is much to be done but we are moving faster than ever before. Great things are starting to happen in Garland and there is a "buzz" across the region that people should be paying attention to Garland. That energy and attention will grow. We can attract more businesses. We can have more opportunities to shop and play.

However, our biggest challenge will be within our neighborhoods. Our economic vitality is directly connected. Those neighborhoods that do the best job of being a community of caring neighbors will gain the most, both within the neighborhood boundaries but also in the area. Those neighborhoods that are best organized will also be the ones to benefit first and the most. Be a part of it! Let's Grow Garland.



#### In Balance—Dave Morgan ONA Treasurer

We are indeed blessed to live in the Oakridge community with so many good neighbors, beautiful residences, and a healthy golf course back in operation. The ONA has had a difficult fiscal year in that we started our membership drive very late after assuming office and, as a result, ended with a very disappointing drop in the number of members. On the other side of the ledger, though, we had a Board that worked very hard to control expenditures to compensate for the loss in revenues. Further, we did a complete makeover of the newsletter in both format and in that we mailed every Oakridge home each and every month. The newsletter advertising revenues covered a significant portion of the slight cost increase, and our advertisers have had some sparkling results from the increased circulation and every month delivery and on a timely basis.

Here is a recap of ONA expenditures for three fiscal years that summarizes how your funding plus the funding from the advertising revenues are spent:

We expect a significant membership revenue increase to cover the projected increase in expenditures of over \$7,600.00 this next fiscal. We have actually jump started this process by already getting ahead on the invoicing – a special edition mailing with an invoice was just published and delivered so that we are months ahead of last year's late start disaster. Reminder invoicing should happen even before last year's late invoicing.

Landscaping and maintenance is way up because we plan on doing a lot of beautification planting. Repairs are projected up because we want to start the conversion from our wasteful sprinklers to drip irrigation. Neighborhood picnics and events are much higher because we must get back to having those occasions to get out and meet our neighbors.

Spending more on our community requires more money being raised. We will be working to bring an ONA membership card into existence if we can get enough surrounding merchants and businesses convinced to provide ONA members discounts on merchandise and services. However, we will need that program to raise enough advertising revenues to more than fully cover that program. Your additional ideas for fund raising like a community "garage sale" would be welcomed.

When a family looking for a new place to live drives into a subdivision that they haven't visited before through a brick walled entrance with manicured green grass and bright colored flowers in clean planting beds, they notice it is a neat neighborhood in which they can expect to pay more for a home. On the other hand, if the grass is dead and the planting beds are full of trash and dead plants they will expect to pay less . How the entrances look effects the home values in the subdivision.

We have been having typical Texas weather lately – winter one day, spring the next, then winter again. Hopefully spring will come to stay soon and we can get busy with our Entrance Beautification Project. The plan is to redo the landscaping at the four main Oakridge entrances – Buckingham/Diamond Oaks, Jupiter/Ridge Oak, Beltline/Laurel Oaks and Shiloh/Big Oaks. This would include drip irrigation and colorful plants. We already have one donation and a promise of another towards this project but we are still far short on funds. The City of Garland will not mow the grass. The City of Garland does not give us free electricity for the sign lights. The City of Garland does not give us free water for the sprinkler and irrigation system. Your ONA dues pay for all of this.

#### **NEW BUSINESS**

Dave Morgan continues to work on the draft ONA Board Policy Manual for board review. **ENVIRONMENTAL** – Don Pattie—Keith Engler will continue to maintain the entrance lights.

Don is still soliciting bids for drip irrigation at the four main entrances.

SAFETY - Bill Olive Solicitors are coming around again; they need to be displaying a city permit. If there are any questions, contact Bill. The fire department will be conducting their "Fill the Boot" campaign on 4/4, 11 and 18/14 at certain intersections.

#### May 2014 Article—Scott LeMay

Many years ago I innocently wandered in to a Camelot Neighborhood Association (CNA) meeting. As a first time homeowner I really had no experience with neighborhood groups of any kind. What I did have was an interest in my home and the safety and security of my family. Going to that meeting has proven to be one of the best decisions in my life. I was inspired by their dedication and I have learned from their experience. I can safely say that had I not gotten involved with CNA I would not be serving on the city council today.

What I found then is what I see the need for all the time now across the city. People, citizens, neighbors who care not just about their homes, but their neighborhoods, to get involved. This applies to mandatory HOA's and most especially voluntary neighborhood associations. Mandatory groups typically have a management company that handles many of the details and duties. Those of us in voluntary groups are truly "do it yourselfers". We handle everything! A common misperception in mandatory groups is that everyone participates. Nothing could be further from the truth. They still struggle with the same issue that voluntary groups do.

So what is that issue? Quite simply, volunteers willing to participate. Your participation in the Oakridge Neighborhood Association (ONA) is a key component in not just maintaining the neighborhood but also ensuring that the neighborhood remains a vital and attractive area in the city. That is a benefit to you, your neighbors and to me. Not just as your city council representative but as a citizen of Garland. Participation has many levels. Some people are comfortable being out front, some are not. Some people are able to give more time and effort than others. That's OK. Your financial support of the association has obvious value and far reaching impact. It allows ONA to do the necessary work that benefits us all.

Cities are sometimes known by industries that are located there, maybe even shopping areas or other amenities. That's fine and understandable. But cities are judged by their neighborhoods. When industries or retailer are looking to locate in a city, they look at the neighborhoods first. When they look at us I want them to see not just neighborhoods that are surviving, but neighborhoods that are thriving.
