City of Garland District 7 Report—Scott LeMay

As I mentioned before a good sign that the economy is picking up can be seen in the amount of zoning cases being heard. You can also see that in the number of relocations and existing company expansions in the area. While many of you have probably read that Raytheon has decided to move their operations to Richardson, I can tell you that more are making the choice to locate here and several well established companies are making the commitment to stay. Many of those like Kraft Foods and MAPEI are also expanding their production facilities. While everyone knows what Kraft makes very few probably know that much about MAPEI. Based out of Italy they are a worldwide leader in the development and production of construction adhesives and sealants. They like Kraft, Atlas Copco, Plastipak and Valspar just to name a few call Garland home and support the community not only with jobs but also as partners in "Growing Garland". That is something that our city staff and your City Council are committed to. If you would like to learn more, just ask.

On May 31st the city will celebrate the re-opening of the Landmark Depot Museum in the new Heritage Crossing location at Sixth and Walnut. During that time there will be activities and exhibits at the Central Library featuring trains and railroad history. I am excited to see the refurbished museum and see all the local artifacts on display again. Council Updates-

At our May 5th Work Session we received a very detailed report from the North Texas Municipal Water District (NTMWD) on our current water status as well as long range projections. There is no real need to cover our current status here because it is well known and discussed. If you have any question as to the severity of our current challenges I will just remind you that the every other week watering schedule has been extended through May. As to our long range projections they are dependent on the approval and funding of new reservoirs and ultimately conservation. The current drought cycle obviously impacts us daily and I am happy to report that we are exceeding our conservation goals. For a city our size that is no small accomplishment. The demands on the system will continue to increase as our region grows. This month we will reconvene our joint meetings with the Plan Commission on the Garland Development Code (GDC). We concluded our first round of meetings in late March. Since that time our excellent Planning Staff has worked to further refine and better define the GDC. Around The District-

I'd like to share a little more good news about our local economic outlook. This is really not just specific to District 7 but you can see the signs all around. The preliminary numbers from DCAD show total tax base increases in both residential and commercial property values that include \$115 million in new construction. The certified values will be finalized in late July. Other positive indicators show an increase in building permit valuations and a decrease in the time residential property is on the market. One of the most positive signs is also a decrease in foreclosed properties across the city. We can only hope that this trend continues and we need to stay focused on moving forward. I think we are in a good position to build on our successes and create new opportunities for the near future. Stay tuned.


