City of Garland District 7 Report—Scott LeMay

As I am sure many of you have heard by now we have adjusted our lawn watering schedule again this year. On August 28th the North Texas Municipal Water District Board voted to allow the member cities to reinstate once a week lawn watering. This schedule will now be in effect through the end of October and will be allowed on your designated trash collection day. While this decision might seem late in the summer watering season it is based on maintaining our water quality. Basically we were so responsible at reducing our water consumption that we were not getting the proper circulation with our water in storage. The water quality in our elevated tanks was degrading due to lack of circulation and heat. Allowing once a week watering in September and October will improve circulation and help Garland Water Utilities ensure our water quality. You may have seen news reports on some of the surrounding cities opening up fire hydrants to increase circulation. While this is certainly a quick way to solve the issue it obviously frustrates many homeowners with parched lawns. We hope to avoid this and it will only be performed if necessary. Once again I applaud our city and residents for their efforts to reduce water consumption. We were asked to reduce by 10% and to date we are well over 20%. For that you have my thanks.

Our annual Healthy Living Expo is scheduled for Saturday, September 27 from 9:00-1:00 at the Curtis Culwell Center. There will be activities, exhibits and information on how to live a healthy lifestyle in a sustainable environment. This event is free and certainly worth your time. Another notable event in September is National Preparedness Month. Our Office of Emergency Management is working with a variety of national, state and local organizations to help educate the public about preparing for emergencies. Council Updates-

We have completed the process of reviewing and approving the proposed 2014-2015 budget. At our September 2nd meeting after much discussion and several failed motions to amend, we approved the budget minus the proposed \$1.92 tax increase. This will hold our tax rate at \$70.46 per \$100k of valuation. That does remove the voter approved and Street Committee recommended increase. The general consensus on the council is that we need to continue to look for ways to increase street funding. We need to remain fiscally responsible and also mindful of the tax burden

on our residents. As I have said before our economic indicators are positive but I feel we should remain cautious about future financial commitments. Garland already carries a higher than average tax rate compared to our surrounding cities. There are many contributing factors to that but we should be aware of that as we work to compete with those cities for new and redevelopment opportunities. We do have a little over \$3 million in surplus from the previous year. The budget also included proposals for those funds for various positions, programs and equipment. Our decision was also to hold that money and take a closer look at the proposals and to also prioritize them for the highest impact. I supported that decision and also the recommendation of a Budget Committee to also advise us. Make no mistake, we will spend it. The key is to spend it wisely. At the same time we did approve the proposed monthly rate increase of \$7.43 for water, wastewater and solid waste collection. Those increases are associated with increased costs for water from the North Texas Municipal Water District, capital improvements to the wastewater system and solid waste collection that will continue funding for the single stream recycling program. Electric and stormwater rates will remain unchanged. This was not an easy decision since I believe we need to be as sensitive to fee increases as we are tax increases. The bottom line for me here was infrastructure improvements and the continuation of our excellent service levels. Speaking of excellent service we also approved the 3% base pay increase for all city personnel. We have held their compensation flat for several years now while giving them some small one time lump sum payments. We were given some stats that showed 61% of our employees were below market rate in pay. I feel strongly that we should take better care of them for the work they do and also be better able to retain and recruit.

District Updates-

We have approved a concept plan for a townhome development at the corner of North Garland and Beltline. It will be very similar to the Shoal Creek development at Campbell and 190. The developer is required to submit a detail plan for final approval. I would imagine this coming back to us later in the fall.



Paid members now have an "ORANGE" flag identifying their willingness to help and we hope you will keep it placed somewhere in the front of your home to signify you "stepped up" to help. You may have to unfurl or reset your flag due to wind and weather. Old flags do not indicate your membership for 2014/2015. The neighborhood is proud of your volunteer membership. The ONA officer/volunteers do not have the responsibility to regulate how you care for your property. However, any citizen of Garland has the right to report violations of the Garland City Code regarding your home and property front, side, and back. I hope you enjoy the community you live in and take advantage of any "extra" privileges membership may offer you. No numbers are presented again this month. We are still early into this fiscal year, and any analysis remains not very meaningful We remain focused on getting members for this fiscal year (June 01, 2014 - May 31, 2015), and we need you to be a part of the ONA! You should have already received our special invoice edition mailing a few weeks ago as this September edition is in your hands as is your ONA discount membership card. If you paid but did not use that "invoice format" to make your membership payment over these past few months, please verify that your check cleared your bank in this fiscal year to make sure your membership is in good order. If you do not have the bright orange ONA member flag in your yard, we do NOT show you having paid for this membership year. Thanks to those of you joining us already!

As you will read elsewhere, the major entrance infrastructure improvements have started BUT will be hard to see untill plantings are done when the weather cools. The ONA discount membership card to MEMBERS ON-LY has been issued and will be accepted at participating businesses in the surrounding area. These folks will provide ONA members with discounts/specials on merchandise and services. Go to "OakridgeNA.org" often to view the growing number of retailer monthly specials as we are getting the program operational over these first few months and beyond.

We are officially re-registered as a City of Garland Neighborhood Based Group.

The City of Garland is holding hearings on updating and consolidating its development codes (including the zoning, subdivision, and site development ordinances) into a comprehensive development code. These hearings will be the next few Thursdays and perhaps beyond. Those days are September 11th, 18th, and 25th at 7;00 pm at 521 West State Street. Current City Code requires that permits be taken out for construction projects BUT not all construction projects. Construction that involves structural changes to your home or new unattached additions (a fence or storage building for example) will almost always require a permit. Further, replacement of an existing hot water heater requires a permit – usually the repair or replacement of an existing fence on the same fence line generally does not require a permit. Doing new plumbing inside or outside (new irrigation systems) requires a permit – putting in replacement countertops do not require a permit. Replacing the air conditioning condensing unit and/or the heating system requires a permit – repairing the air conditioner does not require a permit. If you are doing electrical work, contact the City to see if a permit is needed for the type of work being done. Demolition of swimming pools, interior walls, and entire structures including the slab requires a permit – putting in replacement/new carpet,/tile/wood/laminate flooring does not require a permit. A pool type structure with water to be over 24 inches deep requires a permit. Replacing a roof does not require a permit unless over 25% or more of the decking is replaced. There are other permitting requirements AND they can change from time to time. Deal with reputable construction professionals, and verify their statement that "no permitting is needed" by doing your own "trust but verify" research. Neighbors may state they did get a permit, but they may have accidentally broken code. As a Real Estate Broker, I must advise you that when you sell your home, there is a specific question on the Home Disclosure Form where you declare that you got all required building permits while owning your home. If the City finds a permit was done after you sold your home, and they have the new home owner redo that work, then you are legally on the hook to reimburse the new home owner for his costs - including the permit. Your home survey will also have to be updated. Remember, the common thread in requiring permits is that the City wants your home to be ultimately as safe as reasonably possible for you, all those in your home, and surrounding neighbors for the many, many years to come.
