
A Visit from Fire Station 3 - Bill Olive - ONA Safety Director

We're pleased to report that on February 25th, Captain Brooks and his "band of merry men" from Station 3 will be attending our **next ONA General meeting on Thursday, February 25, 2016.** A word of warning to you, however, as they will be bringing a firetruck and an ambulance and they're planning to arrive around 7 pm. For this reason, we urge all residents planning to attend the meeting to arrive early to ensure you're able to obtain a parking spot. They will be on call that night, so they may have to leave suddenly and will need to have the truck and ambulance ready to go.

Station 3 was the first station to provide service to the Oakridge area and many years ago our neighborhood began providing Christmas dinners to them as a "Thank You." Since then our neighborhood has grown, Garland itself has grown, and now both Station 3 and Station 11 provide service to our area. A few years ago, our neighborhood started providing both Thanksgiving and Christmas dinners to both stations.

Hopefully, Captain Brooks will have a few minutes to answer questions after his overview. If you have other questions regarding fire and emergency medical services, this is your time to ask. Unfortunately, their time with us will be somewhat limited since they will be on duty that evening.

Garland's firemen/EMS are outstanding, and a very big asset to our city. Oakridge Home Values up 9.7% - Dylan Hedrick

The past year was a good year for home values as houses in the Oakridge Neighborhood appreciated 9.7% in the past 12 months according to the online real estate database company Zillow. According to Zillow's Home Value index, the average house price in the neighborhood was \$211,800 with the value projected to rise 6.1% by the end of 2016.

Compared to the national average of 4.0% increase in 2015, and a 2.6% projected increase in 2016, the Oakridge neighborhood is doing quite well comparatively.

Zillow rates Oakridge a 9.3 out of 10 on its Market Health Index, which includes the past and projected growth of home values among other metrics. As of the press date, only two homes were for sale in the neighborhood, according to Zillow. The lack of homes for sale is likely a result of the strength of the housing market in the Dallas area.

According to an article in the Dallas Morning News published in September, the supply of houses in North Texas is at a historical low point which is largely responsible for the rise in cost of residential properties.

Demand for homes is expected to remain strong as corporations such as Toyota and Liberty Mutual Insurance move into new campuses in the region.

ONA Code Compliance Process - Dwight Davis

We will reiterate things with Steve Killen in Code Compliance and with Scott LeMay to get some results.

Oakridge Sign Toppers Proposed for All 75 ONA Street Signs - Dwight Davis, ONA President

The City of Garland's Neighborhood Vitality Matching Grant (VMG) is available to the Oakridge Neighborhood Association. On January 30, 2016, I attended a workshop for all Garland Homeowners and Neighborhood Associations where the details of the available grants were presented. There has been set aside about \$5 Billion dollars for this program for use over an 11 year period. This grant has been going for about five years and they have spent only \$2.5 billion dollars of the grant money. As you may recall, we utilized this grant in 2012 to install a number of vintage black post street lights throughout Oakridge to increase visibility and safety for all.

These grants are designed to empower residents to be able to improve and sustain the various neighborhoods with improved quality of life. Enhancements that improve neighborhood identity and build community pride and that benefit the public at large are considered for this matching grant money.

The ONA has selected street sign toppers as a current project for our neighborhood. There are 75 street signs throughout Oakridge that will need these sign toppers. The cost for each sign topper is \$100. It costs \$35 is to manufacture and paint and \$65 to install each sign. The total for the entire project for the 75 signs is estimated to be \$7,500. The ONA will pay 10% of the cost or \$750 up front. The City of Garland Office of Neighborhood Vitality will pay 90% or the matching grant of \$6,750—which I believe is a very good deal for us. We expect the project to be completed by the end of this summer. Below is a preliminary drawing of the proposed sign topper.
