### Please Mind Your Speed in our Neighborhod

Did you know that the traffic light at the intersection of Shiloh Road and Big Oaks Drive was placed there after serious lobbying by members of the Oakridge Neighborhood Association Board?

Mark Monroe was the City Council person representing Oakridge at the time. Shiloh Road was a speedway. Drivers had a clear run from Beltline to Buckingham and sometimes exceeded speeds of 50 or 60 miles per hour.

It was a real challenge trying to cross Shiloh to get to Holford Park, to drive your kids to Ethridge Elementary School on Sam Houston or just making a left-hand turn onto Shiloh Road.

With persistent conversations with Councilman Monroe, the ONA was able to convince him and the Streets Division that a study should be done to see if a traffic

light should be installed. The study determined that indeed a traffic light would be beneficial. That traffic light cost the Streets Division about \$100,000 at the time, but I'm sure you'll agree it was an excellent investment in our safety.



The posted speed Limit thru the Oakridge Subdivision is 30 miles per hour, but some drivers exceed that limitation by driving 40 and 50 miles per hour especially on Big Oaks and Diamond Oaks Drives.

Some time ago, a radar unit and speed monitoring devices were checking for speeders on Diamond Oaks. The device found that quite a few drivers breaking the law.

While 30 miles per hour sounds like a reasonable speed limit, driving on a street with cars parked on both sides at 25 miles per hour or less can be precarious. And consider the problem of a fire truck or emergency vehicle getting thru that "canyon" of cars and trucks.

Please be mindful of this and if possible, park your vehicles in your driveway, in the alley, or in your garage.
